These lectures identify and review many of the common issues occurring in the clinical supervision of mental health and social services settings and are designed to explore the roles and responsibilities of the supervisor and supervisee towards clearly operationalizing goals and objectives. Participants will discuss common difficulties in supervision; distinguish between administrative and clinical supervision; discuss difficulties with boundary issues; and enhance existing clinical supervision skills using various models and methods to provide a framework for clinical supervision.

After attending this lecture, participants should be able to:

- Distinguish between clinical supervision and clinical consultation.
- Define models, formats, and techniques for effective clinical supervision.
- Recognize and discuss the ethical issues present in clinical supervision.

Introduction to Trauma-Informed Care

This lecture will provide an overview of trauma-informed care in a behavioral health setting. The focus will be to provide information on the neurobiology and social consequences of trauma and how they impact patients in our care. Participants will review effective techniques for discussing trauma as well as methods for providing a trauma-sensitive environment for both patients and behavioral health staff.

- Demonstrate a basic understanding of trauma-informed care in a behavioral healthcare setting.
- Describe the social consequences of trauma.
- Identify strategies to improve self-care to prevent vicarious traumatization.

**Using the Power of Families
in the Healing Process**

The role of the patient's family is critical to the healing process. This lecture will provide a blueprint of some basic concepts of family relationships and build upon these to demonstrate the reciprocity between the family member's diagnosis and patterns of family interaction. Particular attention will be paid to mental illness and substance abuse. Additionally, strategies of working within a family system, even distorted, to design an effective plan for continued recovery after discharge from the hospital will be identified.

After attending this lecture, participants should be able to:

- Outline the fundamental concepts of family systems theory.
- Demonstrate the reciprocal relationship between the illness of a family member and patterns of family interaction, particularly as it manifests in cases of mental illness and substance abuse.
- Identify strategies of working within a family system to design an effective plan for continued recovery after discharge from a psychiatric hospital facility.

Holly Slapinski, ACSW, LCSW-C, provides family therapy in a wide variety of settings. She has served as a university instructor, outpatient clinical supervisor, and federally qualified substance abuse professional. Ms. Slapinski completed structural family therapy training at the prestigious Philadelphia Child Guidance Clinic. Her treatment philosophy stems from the premise that the foundation for individual functioning begins with our primary relationships.
