Program Description

Obsessive-compulsive Disorder (OCD) is a common and often debilitating mental health condition characterized by unwanted intrusive thoughts (obsessions) and repeated distress-reducing behaviors (compulsions). Frequently misunderstood, misdiagnosed, and mistreated, this series of lectures will demystify the disorder and the most effective protocols for helping those who suffer from it. Attendees new to or heavily experienced in treating OCD will gain knowledge on the disorder from multiple perspectives. This unique format features six lectures from top experts in the field, scheduled across three sessions over the spring season.

The series begins at the introductory/intermediate level with an exploration of the essential concepts necessary for diagnosing and treating the disorder effectively, with both cognitive behavioral interventions and the most up to date medication approaches. The second session takes it to the intermediate/advanced level, covering the best practices for treating children with OCD and the most effective strategies for working with family dynamics and treatment refusal. The series ends with advanced lectures on how to maximize exposure-based treatments with an emphasis on inhibitory learning and an exploration of the role of disgust and "not just right experiences" in some manifestations of OCD.
