Obsessive-Compulsive Disorder (OCD) is a common and often debilitating mental health condition characterized by unwanted intrusive thoughts (obsessions) and repeated distress-reducing behaviors (compulsions). Frequently misunderstood, misdiagnosed, and mistreated, this series of lectures will demystify the disorder and the most effective protocols for helping those who suffer from it. Attendees new to or heavily experienced in treating OCD will gain knowledge on the disorder from multiple perspectives. This unique format features six lectures from top experts in the field, scheduled across three sessions over the fall season.

The series begins with two lectures on the treatment of pediatric OCD, both from the cognitive-behavioral and pharmacological perspectives. The second session of lectures explores the system dynamics around OCD, including how to address the impact OCD has on different relationships and the treatment of OCD with co-occurring borderline personality disorder. The series ends with advanced lectures on religious and sexual obsessions in OCD.

1. Identify the psychotherapeutic and psychiatric best-practices for the treatment of pediatric OCD.
2. Conceptualize treatment of OCD and comorbid borderline personality disorder.
