## **Evidence-Based Care for Refugee, Asylee, and Immigrant Patients**

Presented by: Rachel R. Singer, PhD and Renee DeBoard-Lucas, PhD

Individuals may immigrate for a variety of reasons, such as striving to gain access to work or educational opportunities, reunifying with families, or seeking refuge from unsafe circumstances. Mental health symptoms may develop as a result of the individual's initial reasons for fleeing their country of origin but may also be amplified by the very process of seeking safe haven in a new country. The training will describe factors that may impact the mental health of these persons. Participants will engage in interactive discussion, case conceptualization, and creating an action plan for incorporating multiculturally competent interventions into their clinical work.

Rachel Singer, PhD, is a licensed psychologist who specializes in treating anxiety, and multiculturally competent interventions for immigrants, refugees, and asylees. She is the Director of Postdoctoral Training at the Center for Anxiety and Behavioral Change in Rockville, Maryland, and also conducts asylum evaluations for individuals

seeking asylum in the United States. She completed her PhD in Counseling Psychology from Boston College and a postdoctoral fellowship at the Kennedy Krieger Institute at Johns Hopkins. She regularly presents at national conferences and has published on working with immigrants. She received the APA Citizen Psychologist award for her outreach and advocacy with immigrant communities.

Renee DeBoard-Lucas, PhD, is a licensed psychologist with over 15 years of experience treating trauma and anxiety in children, teens, and adults. She is a staff psychologist at Maven Psychology Group and also completes asylum evaluations for people seeking asylum in the United States. She earned her doctorate in Clinical Psychology from Marquette University. She completed a two-year postdoctoral fellowship and then served as a staff psychologist in Child and Adolescent Psychiatry at Johns Hopkins Hospital. Dr. DeBoard-Lucas has authored peer-reviewed articles and book chapters related to children's experiences with trauma as well as mental health needs among refugees and immigrants.

Motivational Interviewing (MI) is a set of therapeutic skills with a strong evidence base in addressing health behaviors and can be used to address any problem behavior. A focus of the workshop will be on using MI to engage people in their mental health treatment, helping people who are unsure how to use treatment or who have reached a plateau in their progress. The workshop will include didactic learning and opportunities to practice MI skills.

She then worked as a clinical psychologist with adults who have co-occurring mental illness and substance use disorders and developed the Sheppard Pratt smoking cessation program. Dr. Smolowitz is focused on developing capacity to improve the lives of people with mental illness.

#### Clinical Suicidology: Innovations in the Assessment and Treatment of Suicidal Risk

Presented by: David Jobes, PhD, ABPP

Clinical suicidology is a growing field with new theories and breakthroughs in the assessment and treatment of suicidal risk. New theories, lines of research, and the use of technology are enabling us to better understand reliable typologies of suicidal states and the evolving nature of suicidal ideation. What the emerging evidence shows is that "one size does not fit all." New developments in the management of suicidal crises along with suicide-focused treatments proven to work through randomized controlled trials (RCT's) are changing the prospects of clinically working with people who are suicidal. It is noteworthy that effective treatments directly target suicide risk independent of psychiatric diagnosis. Finally, new developments in suicide-related policy and a "stepped-care" approach to suicidal risk will be presented.

This presentation meets the requirements of the topics of laws ethics and risk management.

David Jobes, PhD, ABPP, is a Professor of Psychology and Associate Director of Clinical Training at The Catholic University of America and Adjunct Professor of Psychiatry at the Uniformed Services University. An internationally recognized suicidologist, he has authored more than 150 peer-reviewed publications including six books. Dr. Jobes is a past President of the American Association of Suicidology and is the recipient the Edwin Shneidman Award, the Dublin Award, and the Marsha Linehan Award in recognition of his research in clinical suicidology. He maintains a private clinical and forensic practice in Washington, DC.
